The Trades Qualification and Apprenticeship Act (1981) states that in Ontario it is illegal for anyone other than an apprentice, a holder of a valid provisional certificate, or the holder of a valid license called a Certificate of Qualification to do any of the work of a plumber. An apprentice can only do work under the direct supervision of licensed plumber. An owner of a building may do their own plumbing work but cannot employ a person without a license to do the work.
