THE CORPORATION OF THE TOWN OF WHITCHURCH-STOUFFVILLE

BY-LAW NUMBER 97-88-MU

A by-law to designate a certain property as being of Historic and/or Architectural value or interest.

WHEREAS Section 29, Subsection 6 of the Ontario Heritage Act, Chapter 0.18, R.S.O. 1990, authorizes the Council of a municipality to enact by-laws to designate a real property, including all the buildings and structures thereon, to be of historic and/or architectural value or interest;

AND WHEREAS the Council of The Corporation of the Town of Whitchurch-Stouffville has caused to be served on the owners of the lands and premises as outlined hereunder:

Churchill Baptist Church P.O. Box 343, Stouffville, Ontario L4A 7Z6

and upon the Ontario Heritage Foundation, notice of intention to designate the Churchill Baptist Church, Part Lot 21, Concession 8 (former Township of Whitchurch) Town of Whitchurch-Stouffville, Regional Municipal of York, municipally known as 15336 Ninth Line, Stouffville, and has caused notice of intention to be published in a newspaper having a general circulation in the municipality.

AND WHEREAS the reasons for designation are set out in Schedule "A" attached hereto and forming part of this by-law;

- 1. THAT the following real property, being the Church Baptist Church (formerly Church Hill Christian Church), municipally known as 15336 Ninth Line, Stouffville, being in the Town of Whitchurch-Stouffville in the Regional Municipality of York, being Part Lot 21, Concession 8, former Township of Whitchurch, more particularly described as Part 1, Plan R3294, be designated as being of historic and/or architectural value or interest.
- 2. THAT the Town Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described herein in the Land Registry Office.

READ a first and second time this 9th day of June, 1997.
