- 5 Council will be asked to enact the interim tax levy.

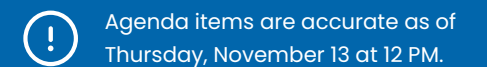


- 1 Council will receive correspondence from the Town of East Gwillimbury regarding an update to the upcoming blue box transition.
